Contributor Membership	\$25,000 USD	Contributor level member companies can participate in all General member activities as well as access the Government Engagement Committee (GEC) and its subsidiary groups. These groups are engaged in review and comment on a wide variety of regulatory, policy, and standardization documents and proposals. This group engages globally and is especially active in the U.S., China, Europe, Japan and India. Contributor members also have the option of applying to participate in the Advisory Council, which sets the direction for the Green Grid.
Small Contributor Membership	\$12,000 USD	Benefits are the same as the Contributor Membership. To qualify as a Small Contributor the company must have gross annual revenues of less than \$100 million USD and complete the TGG Small Contributor verification form.
General Membership	\$6,000 USD	General members can participate in all technical development. This includes the Global Technical Committee (GTC) and its associated standing work groups (SWG) and activity work groups (AWG), which focus on optimizing data center energy and resource efficiency through researching and drafting white papers, creating metrics and tools, and providing technical advice. General members can have multiple participant profiles; that is, all employees of the company can participate.
Small General Membership	\$3,000 USD	Benefits are the same as the General Membership. To qualify for a Small General Membership the company must have less than 50 employees (including full-time contractors) and complete the TGG Small General verification form.
